## DISCHARGE CONSENT ORDER

With reference to the online application no- 2832794 dated 01.08.2019 of M/s Rail Wheel Plant, At & Village-Bela, P.O.-Arvind Nagar, Dariyapur, District- Saran for consent under sections 25/26 of the Water (Prevention & Control of Pollution) Act, 1974, he/they is/are granted consent to operate his/their their Rail Wheel Plant (Capacity-100000 wheel/annum) At & Village-Bela, P.O.-Arvind Nagar, Dariyapur, District- Saran (Chapra) for the period from 03.08.2019 to 02.08.2024 with the following conditions:-

1 That, he/they shall not make any alteration, addition, deletion or modification in the plant without the prior clearance from the Board and shall also abide by the obligations under sections 24, 31 and 33A of the Water (Prevention & Control of Pollution) Act, 1974 and further shall extend co-operation to the

Board in performing its functions entrusted under sections 20,21,23,30 and 32 of the Act;

2 That, he/they shall comply with the requirements of rule 14 of the Environment (Protection) Rules, 1986; provisions (whichever applicable) of the Hazardous And Other Wastes (Management and Transboundary Movement), Rules, 2016, rules 4,5,7,8,10,11,12,13,15 and 18 of the Manufacture, Storage and Import of Hazardous Chemical Rules, 1989; and the provisions of the Public Liability Insurance Act, 1991, whichever is applicable,

3 That, he/they shall monitor his/their effluent(s) regularly and maintain its quality in conformity with

Board's standards and shall produce its proof, as and when asked for

4 That, he/they shall submit application for consent again 30 days before the expiration of the period of consent or within 30 days from the date of receipt of this order, whichever is applicable;

5 That, effluent treatment plant shall be operated to treat the trade effluent so as to achieve the standards

prescribed under the Rules or as directed time to time, whichever is stringent,

6 That, they shall make effort to re-use treated effluent to maintain Zero Liquid Discharge and water consumption shall be reduced by adopting 3 R's (reduce, reuse and recycle) concept;

That, the unit shall not discharge any effluent into the river;

8 That, the Environmental Statement as prescribed in the E (P) Rules, 1986 [see rule 14] for the each

financial year ending the 31<sup>st</sup> March, shall be submitted by the month of September every year,

9 That, in compliance of direction of the Hon'ble Supreme Court and vide Board's HQ ref no. - 2638, dated 09.07.2019, they shall make provisions for display of data outside main factory gate about quantity and quality of water discharge and air emission along with solid waste generated within the factory

10 That, notwithstand any thing stated above, the applicant unit shall abide by all the provisions of the environmental laws including policies and guidelines made there under
