## **EMISSION CONSENT ORDER**

With reference to the online application no- 2832794 dated 01.08.2019 of M/s Rail Wheel Plant, At & Village-Bela, P.O.-Arvind Nagar, Dariyapur, District- Saran for consent under sections 21 of the Air (Prevention & Control of Pollution) Act,1981, he/they is/are granted consent to operate his/their Rail Wheel Plant (Capacity-100000 wheel/annum) At & Village-Bela, P.O.-Arvind Nagar, Dariyapur, District- Saran (Chapra) for the period from 03.08.2019 to 02.08.2024 with the following conditions:-

That, he/they shall not make any alteration, addition, deletion or modification in the plant without the prior clearance from the Board and shall also abide by the obligations under sections 22,23 and 31A of the Air (Prevention & Control of Pollution) Act, 1981 and further shall extend co-operation to the Board in performing its functions entrusted under sections 24,25 and 26 of the Act;

That, he /they shall comply with the requirements of rule 14 of the Environment (Protection) Rules, 1986; provisions (whichever applicable) of the Hazardous And Other Wastes (Management and Transboundary Movement) Rules, 2016; rules 4,5,7,8,10,11,12,13,15,17 and 18 of the Manufacture. Storage and Import of Hazardous Chemical Rules,1989; and the provisions of the Public Liability Insurance Act, 1991, whichever is applicable;

That, he/they shall monitor his/their emission(s) and the ambient air quality from representative point regularly and shall maintain its quality in conformity with Board's standards and shall produce its proof, as and when asked for:

4 That, he/they shall submit application for consent again 30 days before the expiration of the period of consent or within 30 days from the date of receipt of this order, whichever is applicable;

That, they shall submit an action plan with study report to monitor roof top emission from all three electric arc furnaces to the Board within three months;

That, they shall submit monitoring reports of all stacks monthly to the Board and ensure emission of particulate matter ≤ 150 mg/Nm³;

7 That, they shall submit AAQ report (four stations) quarterly to the Board;

8 That, they shall maintain overall noise level in and around the plant within prescribed standard and quarterly report report shall be submitted to the Board;

That, the solid waste (if any) shall be disposed of properly at designated place and a monthly report containing quantity of generation, re-used, if any and disposed, site of disposal etc shall be submitted to the Board.

10 That, the Environmental Statement as prescribed in the E (P) Rules, 1986 [see rule 14] for the each financial year ending the 31<sup>st</sup> March, shall be submitted by the month of September every year,

11 That, good housekeeping shall be maintained;

12 That, tree plantation shall be done with consultation of local DFO office to develop as green belt,

That, in compliance of direction of the Hon'ble Supreme Court and vide Board's HQ ref no.- 2638, dated 09.07.2019, they shall make provisions for display of data outside main factory gate about quantity and quality of water discharge and air emission along with solid waste generated within the factory premises; and

14 That, notwithstand any thing stated above, the applicant unit shall abide by all the provisions of the environmental laws including policies and guidelines made there under.
