

## RAIL WHEEL PLANT, BELA

**Notification No: E/RWP/Bela/Gaz/CMPs Dated: 02.09.2024**

**"Walk-in-Interview" for engagement of Contract Medical Practitioners (CMPs) in RWP/Bela.**

"Walk-in-Interview" will be conducted by Rail Wheel Plant, Bela (Saran) Bihar for engagement of 02 posts of General Duty Medical Officer on contract basis for Rail Wheel Plant, Bela (Saran) Bihar. Willing Doctors who fulfill the qualification/eligibility criteria specified below may apply for the above engagement. The engagement will be purely on Contract basis for the period of one year which can be renewed as a fresh contract on year to year basis (not extendable beyond 12 years) or till the post filled by regular Doctors selected from UPSC or the scheme is available whichever is earlier.

**1. CMP/GDMO (Full time)**

**(A) Vacancies :**

**(B) Qualification :**

- MBBS with internship.
- Experience of ICU/Emergency duty.
- Higher qualification will be preferred for both the posts.
- Registered with Medical Council of India/Medical Council of State.

**(C) Remuneration:**

Rs.75,000/- (Rupees Seventy five thousand only) per month, if Railway accommodation is not provided. If Railway accommodation is provided, deduction will be made from the monthly remuneration equivalent to House Rent Allowance payable on minimum pay to Junior Scale officer (Level-10 in 7<sup>th</sup> CPC) and fixed license fee for accommodation.

**2. Age limit:** - Not exceeding 53 years as on **04.09.2024**, which will be relaxable by 05 (five) years for candidates belonging to SC/ST community & 03 (three) years for OBC as the case may be.

**3. Community break-up of total vacancies :** UR-02; SC- NIL ; ST-NIL & OBC- NIL (**Total – 02**)

**Retired IRMS officers,** Retired Government Medical Officers of State Government and Central Government and PSUs may also apply against above vacancies. The condition will be as under:-

(i) **Age:-** Not exceeding 67 years as on **04.09.2024**.

(ii) **Qualification:-** Degree/Diploma in *corresponding speciality*, the minimum qualification required is MBBS.

**5. Remuneration:-** Fixed remuneration of Rs.75,000/ (Rupees Seventy five thousand only) per month, subject to condition that remuneration + pension should not exceed the last pay drawn by Retired Doctors. It is not applicable to retired doctors from PSUs (whose service is not pensionable)

The engagement of retired doctors will be purely on Contract basis for the period of one year which can be renewed as a fresh contract on year to year basis (not extendable beyond 7 terms or 67 year of age which is earlier) or till the post filled by regular Doctors selected from UPSC or the scheme is available whichever is earlier.

**6. How to apply:-**

Candidates intending to join as Contract Medical Practitioner should apply on prescribed format (enclosed) and submit the same up to 10.30 A.M on the date of interview at the venue along with self attested photocopies of following documents and attend the "Walk-in-Interview" with original certificates mentioned below:-



- a. Proof of age.
- b. Proof of passing MBBS, Internship, Degree, Diploma & other educational qualifications and certificate regarding experiences.
- c. Proof of registration in Indian Medical Council/Medical Council of State.
- d. Proof of caste in case of SC/ST candidate & non-creamy layer certificate in case of OBC candidates. (only on prescribed format for Central Government will be accepted in case of OBC).
- e. Mark Sheet(s) of relevant qualification(s).
- f. 04 (four) copies of recent passport size photograph with self signature.
- g. Original Pension Payment Order book & self attested copy of the same in case of Retd. Doctor.
- h. Aadhar card.

**7. General Conditions and other facilities:-**

- a. In the event of absence from duty, deduction from the remuneration will be applicable @ daily rate of proportionate of remuneration.
  - b. Railway administration has legitimate right to deploy the engaged CMP(s) any where/any time over Rail Wheel Plant, Bela in case of administrative exigency.
  - c. One set of 1<sup>st</sup> class complementary pass for self and family shall be issued during each contract period after completion of three months of regular contract service. Contract Medical Practitioner can avail free medical treatment on Rail Wheel Plant, Bela Hospital for self only.
  - d. No TA/DA will be paid to the candidates for attending the interview.
  - e. Selected candidates will posted at Rail Wheel Plant, Bela (Saran) Bihar.
  - f. CMP will have no right of posting against regular vacant post or transfer at his own request.
  - g. CMP is not be allowed private practice after sanction of contract.
  - h. The candidates working in any Medical Organization/State Govt. should submit their applications through proper channel with "No Objection certificate".
  - i. There may be change in numbers of vacancies and place of posting as specified above depending upon administrative requirement. Offer of posting will be made on the basis of availability of vacancies at the time of engagement.
  - j. Posts indicated herein may be kept unfilled at the discretion of Railway administration.
  - k. Contract Medical Practitioners engaged on contract basis in the Railway will not have any claim or right for his/her continuity in service or automatic extension of the term of contract service. The service rendered as CMP will not confer the right to take weightage for regular selection through UPSC and also will not confer any right for regularization or absorption.
  - l. If Railway accommodation is provided to the CMPs subject to availability and after meeting the requirement of serving Railway officers, an amount equivalent to HRA payable to afresh entrant to Group 'A' Junior Scale/Sr. Scale and license fee of the Railway accommodation will be deducted from the monthly remuneration payable to the Contract Medical Practitioner.
  - m. In case Specialists are not available against the vacancies as notified, Railway Administration reserve the right to engage General Duty Doctors against these vacancies.
  - n. Offer of engagement will be issued in favour of selected candidates. The candidates should report within 15 days from the date of issue of offer letter. For candidates not reporting within stipulated time, offer may be cancelled.
  - o. The contract of the CMPs can be terminated by the Railway at any time during the contract period by giving 15 days notice without assigning any reason as per the terms and conditions laid down vide railway Board's letter No. 2000/H-1/12/27/Pt.I dated 06.10.2000.
8. Candidates should report with original relevant documents for "Walk-in-Interview" at the venue mentioned above at 10.30 Hrs. to 11.30 Hrs. on the date of interview positively otherwise their application will not be entertained.


